**SUPPLEMENTARY REGULATIONS:**

1. JURISDICTION: An event for solo motorcycles, held under the National Sporting Code and the Safety Code of O.R.P.A.
2. ELIGIBILITY: Open to registered/licensed youth members of O.R.P.A. solo (enduro, motocross, trail and trial type) motorcycles.
3. VENUE: Chickwell Farm, Hemington, Nr Radstock BA3 5XT
4. COURSE: Cross country loop consisting of woodland, open fields and other various natural obstacles. Course will be marked with orange arrows and track tape. Where 2 arrows mark a gate riders must pass through. GREEN ARROWS indicate an alternative/easy route. Course cutters will be excluded
5. CLASSES: Group 1 - age 14-16 (125-2T or 250F) Group 2 - age 12-14 (85cc 2-T or 150cc 4-T B/W) Group 3 - age 9-12 (85cc 2-T) Group 4 - age 6-9 (65cc 2-T or 100cc 4T)
6. SCRUTINEERING/SIGNING ON: 1pm to 2.30pm. You must scrutineer first to obtain a pass to sign on.. Race duration 1. 5 hours
7. TYRES: Motocross tyres are recommended.
8. ENTRIES: To be made on the form provided and sent to the secretary of the meeting together with the correct fee and a S.A.E. Payment by cheque only made payable to **MIDWEST MOTORCYCLE CLUB LTD**. Closing date 9<sup>th</sup> October 2011.
9. ENTRY FEES: Club Member £30.00 or **Late Entry/Non Member** £35.00 after closing date. Club Membership £15.00
10. NON-STARTERS AND ABANDONMENT: Anyone who enters for this meeting and does not take part must give satisfactory reason for his/her absence to the secretary of the meeting in writing, within 7 days of the event. Entry fees may only be refunded up to 7 days before the event. In the event of an unavoidable cancellation the organisers may retain £10.00 to cover administration and other cancellation costs.
11. **SIGHTING LAP**: Will be a visual inspection of the course on foot available from 9am the day before the event and up to 1 hour prior to the start. We recommend all riders do walk the course. **REFUELING/WORK AREA: RIDER ONLY IN THIS AREA PLUS 1 ADULT ONLY**
12. **LAP SCORING**: Will be by a transponder worn on the wrist like a watch. You must either buy one for life at a cost of £10. If you forget yours you can hire a tag from us on the day at a cost of £5. You must slow to walking pace to register on the electronic lap scoring system. It is your responsibility to register each lap, failure to slow may result in missing a lap. You must return your hired transponder at the finish.
13. AWARDS: As per championship. Club members only.
14. NO TEAR OFFS ALLOWED ON GOGGLES. ROLL-OFFS ONLY. **NOISE LIMIT 94 dBA All MX bikes will be checked. No refund if you fail**
15. **FINISHERS**: YOU MUST CROSS THE FINISH LINE AFTER THE CHEQURED FLAG HAS BEEN SHOWN TO BE CLASSED AS A FINISHER TO GET A RESULT, OTHERWISE YOU WILL BE CLASSED AS A DNF (DID NOT FINISH).
