## SUPPLEMENTARY REGULATIONS:

- 1.JURISDICTION: An event for solo motorcycles, held under the National Sporting Code and the Safety Code of O.R.P.A.
- 2.ELIGIBILITY: Open to registered/licensed adult members of O.R.P.A. solo (enduro, motocross, trail and trial type) motorcycles.
- 3.VENUE: Cheyne Court Farm, Ditteridge, Box near Bath SN13 8QS. Signed off the A4 Box to Bath road
- 4.COURSE: Cross country loop consisting of woodland, open fields and other various natural obstacles. Course will be marked with orange arrows and track tape. Where 2 arrows mark a gate riders must pass through. GREEN ARROWS indicate an alternative/easy route.Course cutters will be excluded
- 5.CLASSES: EXPERT VETERAN EXPERT CLUBMAN 2T CLUBMAN 4T VETERAN SPORTSMAN 2T SPORTSMAN 4T
- 6.SCRUTINEERING/SIGNING ON: 8:30am to 10:30am. You must scrutineer first to obtain a pass to sign on.
- 7.TYRES: Motocross tyres are recommended.
- 8.ENTRIES: To be made on the form provided and sent to the secretary of the meeting together with the correct fee and a S.A.E. Payment by cheque only made payable to MIDWEST MOTORCYCLE CLUB LTD. Closing date 15th November 2009. Day licence £5.00.
- 9.ENTRY FEES: Club Member £45.00 or Late Entry £50.00 after closing date. Club Membership £25.00
- 10.NON-STARTERS AND ABANDONMENT: Anyone who enters for this meeting and does not take part must give satisfactory reason for his/her absence to the secretary of the meeting in writing, within 7 days of the event. Entry fees may only be refunded up to 7 days before the event. In the event of unavoidable cancellation the organisers may retain £10.00 to cover administration and other cancellation costs.
- 11.SIGHTING LAP : Will be a visual inspection of the course on foot available from 9am the day before the event and up to 1 hour prior to the start. We recommend all riders do walk the course. RE-FUELING/WORK AREA: RIDER ONLY IN THIS AREA NO OTHER PERSON ALLOWED
- 12.LAP SCORING: Will be by a transponder worn on the wrist like a watch. You must either buy one for life at a cost of £10. If you forget yours you can hire a tag from us on the day at a cost of £5. You must slow to walking pace to register on the electronic lap scoring system. It is your responsibility to register each lap, failure to slow may result in missing a lap. You must return your hired transponder at the finish.
- 13.AWARDS: As per championship. Club members only.
- 14.NO TEAR OFFS ALLOWED ON GOGGLES. ROLL-OFFS ONLY. NOISE LIMIT 94 dBA All MX bikes will be checked. No refund if you fail
- 15.FINISHERS: YOU MUST CROSS THE FINISH LINE AFTER THE CHEQUED FLAG HAS BEEN SHOWN TO BE CLASSED AS A FINISHER TO GET A RESULT, OTHERWISE YOU WILL BE CLASSED AS A DNF (DID NOT FINISH).
